The Ministry of the Environment and Natural Resources issued a Decree extending the deadline for submitting authorization requests for rendering tourist services within protected natural areas.

In order to reduce exposure to and transmission of the SARS-CoV2 virus (COVID-19) and protect the health of the general population, since March 2020, the Federal Government suspended non-essential activities, including several services rendered by the Ministries and other governmental agencies. Currently, the offices of the Administrative Units of the National Commission for Protected Natural Areas operate on restricted days and hours. Also, certain filings and authorizations have been suspended.

In order to support the providers of tourist services' obtaining the respective authorization, the Ministry of the Environment and Natural Resources issued in the Official Gazette of the Federation, on November 24, 2020, a decree through which the period for receiving applications for the provision of tourist services is extended until **December 31, 2020**.

Specifically, the deadline for submitting the following applications registered in the Federal Registry of Procedures and Services, is extended:

» "Authorization to carry out recreational tourist

activities within Protected Natural Areas. Modality: Recreational tourist activities with vehicles or transportation unit" with procedure number CNANP-00-014-A;

» "Authorization to carry out recreational tourist activities within Protected Natural Areas. Modality: Recreational tourist activities without vehicles or transportation unit", with procedure number NANP-00-014-B;

» "Authorization to carry out recreational tourist activities within Protected Natural Areas. Modality: Recreational tourist activities with infrastructure", with procedure number CNANP-00-014-C.
